The statutory auditors of the Company have carried out a limited review of the above statement for the quarter and nine months ended 31 December 2019 and an unmodified opinion has been issued. The same have been filed with BSE Ltd. and National Stock Exchange of India Ltd. and is also available on the Company's website at www.cebbco.com.

 During the previous year, the lenders of the Company have completed the Resolution Plan for restructuring of debts in the Company. The Resolution Plan mainly includes partial waiver of the principal amount of loan and interest, issuance of 3,45,39,693 equity shares of Rs. 10 each to the Incoming Investor, transfer of pledged promoter shares to the incoming investor, grant/renewal of the credit facilities subject to certain terms and conditions and issuance of non-convertible redeemable preference shares. The above plan received shareholders approval on 7 January 2019. 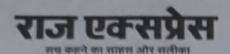
