# Jupiter Electric Mobility Unveils First Showroom in Bengaluru, Marks Beginning of Pan India Expansion

Jupiter Electric Mobility Drives into Karnataka with e-LCVs, Targets Last-Mile Delivery Ecosystem Across India

**National: June 9, 2025**: Jupiter Electric Mobility Pvt. Ltd. (JEM), the electric commercial vehicle arm of Jupiter Wagons Ltd., has inaugurated its maiden showroom in Jayanagar, in the heart of the city, Bengaluru, introducing its 1.05 ton 4-wheeler electric light commercial vehicle (eLCV) – JEM TEZ to one of India's most vibrant urban logistics markets. With a certified range of over 190 km, 80kW peak motor power, 23% gradeability, and a payload capacity of 1.05 tons, it is engineered to deliver high performance, low operating costs, and enhanced reliability. The vehicle is ideally suited for intra-city freight movement, last-mile delivery, and FMCG distribution — sectors where uptime, load efficiency, and emissions reduction are critical business drivers.

The choice of Bengaluru as a launch market also reflects JEM's overall commercial strategy. Bengaluru, being an important logistics and technology hub with an existing ecosystem for EV uptake, presents strong commercial prospects for electrification. Situated in a high-density commercial area, the Jayanagar showroom is easily accessible to fleet operators and logistics players.
