Pursuant to Regulation 30 and Regulation 31A(8) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Company has received a request letter dated August 05, 2025, from Ms. Sagarika Gupta, one of the Promoter of the Company, holding 55,100 equity shares representing 0.01% of the total equity share capital of the Company, seeking reclassification of her shareholding from the 'Promoter and Promoter Group' category to 'Public' category.

The above re-classification request is subject to the analysis of the Board of Directors of the Company and approval of the National Stock Exchange of India Limited and BSE Limited and other applicable conditions as specified under the provisions of Regulation 31A of the SEBI Listing Regulations.

Sub: Request for re-classification from the 'promoter' category to 'public' category of Jupiter Wagons Limited (the "Company") under Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations")

Dear Sir/Madam.

I, Sagarika Gupta, currently holding 55,100 equity shares of face value of ₹10 each in the Company, constituting 0.01% of the total equity share capital. These equity shares were transmitted to me upon the demise of my father and the erstwhile Promoter, Late Samir Kumar Gupta.

Pursuant to the transmission and in accordance with the provisions of the Regulation 31A of the SEBI Listing Regulations, I have been classified as a 'Promoters and Promoter group' category shareholder in the shareholding pattern submitted by the Company with the BSE Limited and National Stock Exchange of India Limited (together referred as the "Stock Exchanges").

I do not exercise any control over the Company, nor I am involved in the management of the Company. I also do not hold any special rights in the Company through formal or informal arrangements. Accordingly, I seek reclassification of my shareholding status from 'Promoter' category to 'Public' category, subject to necessary approvals from the Board of Directors, stock exchanges and any other regulatory authorities, as may be required.

In support of my request, I hereby confirm and certify the following as required in Clause (b) of Regulation 31A(3) of the SEBI Listing Regulations that:

- 1. I and the "persons related to me":
 - i. do not together, hold more than ten percent of the total voting rights in the Company;
 - ii. do not exercise control over the affairs of the Company directly or indirectly;
 - iii. do not have any special rights with respect to the Company through formal or informal arrangements including through any shareholder agreements;
 - iv. shall not be represented on the board of directors (including not having a nominee director) of the Company;
 - v. shall not act as a key managerial personnel in the Company;
 - vi. are not a 'wilful defaulter' as per the Reserve Bank of India Guidelines;
 - vii. are not a fugitive economic offender.

- 2. There is no pending regulatory action against me.
- 3. I shall continue to comply with the conditions mentioned under sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31A(3) of the SEBI Listing Regulations, at all times from the date of re-classification, failing which I shall automatically be reclassified as promoter/person belonging to the promoter group of the Company.
- 4. I shall comply with the conditions mentioned under sub-clauses (iv) and (v) of clause (b) of Regulation 31A(3) of the SEBI Listing Regulations for a period of not less than three years from the date of such re-classification, failing which, I shall automatically be reclassified as promoter/person belonging to the promoter group of the Company.

In light of the above, I request to the Board of Directors to consider and approve my request for re-classification from 'Promoter' category to 'Public' category and initiate the necessary process, including filing the requisite application with the Stock Exchanges in compliance with Regulation 31A of the SEBI Listing Regulations.
